**Composition**: 100 mM sodium phosphate dibasic, 20 mM potassium phosphate monobasic, 27 mM KCl and 1.37 M NaCl. Prepared in 18.2 megohms water and filtered through 1-micron filter. To make 1X, dilute 10-fold with DI water.
